

Moats, Fishponds and other water features in the Forest of Dean and adjoining parishes.

## DEAN ARCHAEOLOGICAL GROUP

#### MOATED SITES SURVEY

This survey has had a long gestation period. In March 1995, David Wilson (author of Moated Sites, Shire Archaeology) came to Gloucester to give a talk on Moated Sites to GADARG. This was reported in DAG Newsletter and members were asked to volunteer to research moats in the Forest of Dean. Subsequently member, Robert Phelps, took his A Level through Distance Learning at Sherwood College, and chose as his project 'Moated Sites'. As part of that project David Wilson was contacted, and joined a group of DAG members in a Moated Site walk from Huntley to Ocle Clifford.

The DAG 'Coffee-Time Archaeology' group has recently completed a research survey on Deserted Settlements of the Forest of Dean and Surrounding Parishes, and decided that as during that research they had visited so many sites with moats on them, either as part of a deserted settlement, or mis-reported as such, it would be appropriate to continue their activities with a research survey into 'Moated Sites, Fishponds and other Water Features' of the Forest of Dean and adjoining parishes.

The process is very much the same as the Deserted Settlement Survey. Sites and Monuments Records are obtained and listed in 'Hundred' order from Westbury (detached) northwards. For each record a small extract of the relevant Tithe map, as redrawn by Geoff Gwatkins, would be marked with the site, and another member would again provide simple sketch maps of the locations.


As in the Deserted Settlement Survey, we have an earlier map and list to work with. This is the late Barbara Rawes' article, 'A Preliminary Check List of Moated Sites in Gloucestershire', published in Glevensis No.12, 1978. The part of the map illustrating sites in the Forest of Dean and west Gloucestershire would be printed and included in the survey report, and the sites so numbered included in the research.

The relevant Victoria County Histories and Verey's Buildings of the Forest and Vale would be consulted to provide any further information. As weather and time allowed each of the listed sites would be visited by two or more members, and a thumbnail description of its present condition recorded. Any of the Group's ideas of corrections to the Sites and Monuments Record would be discussed with the appropriate officer at Shire Hall, and any previously unrecorded sites brought to his notice.


Finally, the complete survey would be printed in sufficient numbers to allow it to be placed where its information could be most easily accessed. An attempt would then be made to persuade a member to write a 'public faced' book on moated sites, fishponds and other water features.

A copy of the survey would be lodged with the Sites and Monuments Record, and with the Local Studies Library at Cinderford Public Library, plus additional copies printed to be available to any members wishing to have their own. It will be appreciated that the Sites and Monuments Record also included wells, but these it is considered are worthy of a separate study, and so they are not considered in this survey. Fishponds are covered simply because in many cases a fishpond was associated with a moat in the whole of the fish raising business, as are 'other water features', which is possibly a 'catch-all' name to cover those sites that are now part of a water garden feature, but may originally have been part of a fishpond/moat site.

FOREST OF DEAN DISTRICT COUNCIL BOUNDARY





#### BADHAMS COURT

Hundred: Westbury (detached)

Name: Badhams Court SMR: 1010 Area 5058

Status:

NOT on Rawes map.

SMR Description:

(3) No trace of moat during field investigation and (5) no trace of possible moat.

VCH.Vol.X.p.65.

The ancient manor of Beachley manor was evidently at Badhams Court in Sedbury which was recorded in the possession of John ap Thomlyn in 1448. The name is evidently a corruption of ap Adam and the family presumably occupied a house there for a time in the 13th and 14th centuries, but from 1448 the premises were granted on long leases by the lords of the manor...

There was probably no longer a habitable house there by 1676...

It is probable that the ancient manor house occupied another site just to the southeast in the field which was called Old Badhams Court in 1843, and it was presumably there that ruins and traces of a moat were observed c.1860. (Ormerod, Strigulensia, 98)

DAG Moated Sites Survey 1998.

Reported water feature at ST 549 938 (Plot 202 on Tithe map) now completely filled in and unrecognisible.


Water filled rectangular feature at ST 5505 9375, as shown on Tithe map extract, Old Badhams Court, Plot 140. Evidence of some rubble infilling between this and next pond at ST 5498 9372. This pond almost unidentifiable – overgrown, boggy, little standing water and some evidence of tipping to fill it.

The whole considered to be fishponds rather than a moat. Evidence from Tithe map 139 Fishponds confirms.




OS.OL.14,1997, shows an U-shaped moat, plus straight length foot of Hanley Hill. Tithe map shows water with island and straight length.

DAG Moated Sites Survey 1998.

U-shaped moat and straight length of water as recorded on OS.OL14 1997 map still visible (a perched moat?) Interior is a raised mound, very sandy soil, possibly imported.

Considered to be the remains of a moated coney (rabbit) warren. No local information from the landowner.





#### WOOLASTONE GRANGE


Hundred: Westbury (detached) Name: Woolaston Grange SMR 12879: Status: NOT on Rawes map.

DAG Moated Sites Survey 1998.

Parish: Woolaston NGR: ST 5875 9840

Elizabeth Townley (Published in Archaeology in the Severn Estuary, 1998, Vol 9). Fishponds were constructed at Woolaston Grange. The stream leading into Grange Pill was straightened in the area to the south of the Grange buildings, just above high tide level. A channel was dug enclosing the remaining sides of a field into which a series of four graded fish ponds were subsequently dug. Use of sluices would have allowed water to be diverted into and out of the ponds. Run off from the hill could also be removed via the southern channel which curved round the ridge and furrow in the field below, before returning to the main channel. Earthworks suggest sluices near the south of the ponds against the tide.

## PLUSTERWINE



#### Moated Sites

#### PLUSTERWINE

Hundred: Westbury (detached) Name: Plusterwine SMR 1010 Area 5027: Status:

No.112 on Rawes map.

SMR Description:

(1) Earthworks, certainly not a moat and (3) recorded as a moated site. VCH.Vol.X.p.108.

The estate centred on Plusterwine House was evidently not part of the Tintern Abbey estate, for, unlike all the other land in the parish that had belonged to the abbey, it was subject to tithe in 1842 and is not recorded as part of the Beaufort estate. The house, however, stands only a short distance east of Plusterwine Farm and there was a considerable house on the site in the Middle Ages....


In the farmyard, incorporated in the end wall of an out-building used as a pigsty in 1969, is the base of a stone chimney with, on its inner face, a late medieval fireplace...

As the chimney appears to be standing *in situ* it evidently marks the position of a dwelling house at Plusterwine which preceded the present one. An even earlier house may have occupied the moated site to the south-west; in 1969 the site was almost level and the outline of the moat indiscernible

DAG Moated Sites Survey 1998.

Moat at ST 595 994 now completely levelled and indiscernible. The water feature, probably straight arm of the earlier moat, alongside road is still water filled, the large area behind it, now filled with scrub and willow, but no longer water filled. The entrance between two early buildings on roadside now not used but clearly discernable.

#### PRIOR'S LODCE

Hundred: Bledisloe Name: Prior's Lodge SMR: 9930 Status: NOT on Rawes map. Parish: Lydney NGR: SO 5985 0470

VCH.Vol.V.p.68. Prior's Lodge incorporates at its west end a small L-shaped house of the earlier 17th century...


Just below the house on Park brook there was a small lake called Prior's (or Chelfridge) pool in 1608, possibly a fishpond dating from Llanthony priory's ownership....(*P.R.O., MR 879 (F 17/1)*).

DAG Moated Sites Survey 1998.

The VCH entry is obviously incorrect. Prior's Pool is a large lake in the gardens of Prior's Lodge at SO 5985 0470, visited by kind permission of Mr.Melville Watts. Chelfridge Pool is in Upper Old Bargain Wood at SO 6015 0425 still fully recognisable as a fishpond and should we consider be recorded on the SMR.

Priors Meene was not covered by the tithe map and nos preseded by 'P' are from sale particulars for part of Priors Meene Warren in the tithing of Ayleburton and parish of Lydney 1842. (G.R.O. D.1386)

#### PRIOR'S MEENE WARREN

Hundred: Bledisloe Name: Prior's Meene Warren Parish: Aylburton NGR: SO 5948 0396

SMR 1010 Area 5090

Status:

NOT on Rawes map.

SMR Description:

Possible moated homestead, remains of moat but so much landscaping that all trace of original shape now lost.

VCH Vol.V. p.58.

The south part of the Prior's Mesne estate, a former coney warren, was sold in the 1830s and later formed the grounds of three houses. P.68.


The southern part of Prior's Mesne, comprising a large coney warren was sold by the Winters...and it later formed the pleasure grounds for a number of houses. GDR T1/117 Deeds in possession of Mr.Melville Watts.

DAG Moated Sites Survey 1998

A very difficult site both for access and to make sense of. It is a wet area in the middle of Larch Wood, access by tracks at the rear of two houses at Prior's Mesne. There are three areas of water, one fairly large surrounded by bog. Whole area churned up by horses kept there, and unable to recognize any former moat. The site is on a spring line which has possibly destroyed any identifiable traces.


Hundred: Bledisloe Parish: Awre Name: Poulton Court NGR: SO 692 066 SMR 1010 Area 5129 Status No.6. on Rawes map. SMR Description: Site visible on aerial photos. Field name Moat Mead: VCH.Vol.V.p.26/7. Soon after the Conquest William FitzOsbern formed a single estate of Nass and Purton, in Lydney, and a third manor called Pontune. Pontune can be identified with the manor of Poulton in Awre, which later formed a separate estate... The medieval dwelling at Poulton Court was presumably within the circular moat which survives there... DAG Moated Sites Survey 1998.

Site visited, sub-circular moat still clearly remains with a high platform inside.


#### LITTLE BOX

Hundred: Bledisloe Name: Little Box SMR: 1010 Area 19901 Status: NOT on Rawes map. SMR Description: Parish: Awre NGR.: SO 691 072

At eastern end of Rawlings Mead, to south east of Little Box Farm. An U-shaped feature on 1834 Tithe map, but field now truncated by road and rail construction. A former channel linking the moat with the brook downstream partially destroyed. DAG Moated Site Survey 1998.

Site still shows as hollows in field, no longer any water but probably holds water in winter months. Permission obtained to enter field, the whole U-shape of the moat as seen on Tithe map extract could be seen in buttercups and water plantains.

THE LYPIATT (Awre)



#### THE LYPIATT (Awre)

Hundred: Bledisloe

Parish: Awre

Name: The Lypiatt (Awre) SMR: 1010 Area 4352 NGR. SO 710 080

NOT on Rawes map.

Status:

SMR Description:

Small rectangular earthwork, SE of Awre church, possibly part of a small moat. Visible on aerial photos.

VCH.Vol.V.p.17.

The medieval manor house called the Lypiatt once stood east of the Churchend above the level.

p.25. It was presumably the house later called the Lypiatt, which stood on Marsh Lane, east of Awre church and was regarded as the manor house in the 17th century. In 1796 the Lypiatt was a stone-built house of 10 rooms. It was demolished in the mid 19th century, before 1879.

DAG Moated Site Survey 1998.

The NCR quoted in SMR appears to be a 'general location', nothing at the actual site. The area south and east of Awre church has a number of water features and these were all investigated. They have been added to the Tithe map extract and numbered 1 to 4.


No.1. at SO 7095 0775 appears to be a common stock watering facility.


No.2. at SO 7115 0810 with ponds either side of the track appears to be the site of the lost medieval manor of the Lypiatts, a number of holloways and house platforms can be seen in both fields. Suggest this is the one noted by SMR aerial photos.

No.3. at SO 7130 0795 very heavily overgrown but at junction of four fields is most likely to be a stock watering facility.

No.4. at SO 7180 0815 is the remains of Hayward House, now just stones and a damp hollow which may or may not have been associated with the house.

The Lypiatt is recorded in 1624, and is presumed to derive its name from *hliep-geat* (as all 21 other examples of the name in Gloucestershire) which translates as: A gate in an enclosure fence which deer can leap through. Earthworks in the vicinity of the site certainly suggest this. St.BRIAVELS CASTLE

#### St.BRIAVELS CASTLE

Hundred: St.Briavels Name: St.Briavels Castle SMR: 1010 Area 15 Status: SAM 461 LB1 NOT on Rawes map. SMR Description: Notes (2) and (3) refer to the moat garden. VCH.Vol.V.p.257/8. Parish: St.Briavels NGR: SO 558 045

St.Briavels castle stands in the village on the edge of a ridge at c.200m. above the River Wye. The earliest part of the defences was evidently the low motte at the south. It presumably carried a stone or timber tower by 1130, but later in the 12th century a square keep, said to have been c.100 ft. high was built on the motte. Probably by the early 13th century a curtain wall was built, raised on an earth bank and surrounded by a broad moat...


The moat was drained in the mid 19th century, and after 1961 a Moat Society, formed by the villagers, cleared it of undergrowth and laid it out as a public garden... (TBCAS.iii.325-367)

DAG Moated Site Survey 1998.

As reported, moat now a public garden.

#### WILLSBURY

Hundred: St.Briavels Name: Willsbury SMR: Status: NOT on Rawes map. VCH.Vol.V.p.261/2. Parish: St.Briavels NGR: SO 587 037


At Willsbury, adjoining Rodmore to the north-east, Adam, the reeve of St.Briavels manor, apparently acting illegally, built a house shortly before 1270... At the south end of the farm, near Rodmore grove, the owners had a large fishpond in 1689. By the mid 19th century it had been filled in. (*Clos.R.O. D 177*)

Willsbury estate papers, D 421/L 4 Gough farm deeds)

This site accessed from the 'Gloucestershire Way', no trace of site.

#### WELINTON



#### WELINTON

Hundred: St.Briavels Name: Welinton SMR:1010 Area 5610 Status: NOT on Rawes map.

SMR Description:

On a former moated site at Spout Farm there are now farm buildings and yards; its situation at the head of a valley suggests that it would have been spring-fed. A map of 1608 clearly shows a roughly rectangular moated enclosure surrounding a small building.

VCH.Vol.V.p.202,214.

They probably included a dwelling or dwellings near the source of the stream called Black brook on the Monmouth road north of the hill, and it was perhaps there that the name Welinton, used in the early 13th century for the area that the church was built to serve, may have originated; the name is thought to mean a farmstead by a wllow copse, and there is an ancient moated site on Black brook on the west side of the Monmouth road...

A house within the moat became the residence of the priest of Greyndours' chantry in Newland church in 1446, and it was demolished in the 18th century...

Lands on the north side of Newland village which belonged in the mid 15th century to the Clearwell estate included a moated site at the head of Black brook, possibly the original residence of the Jose family. In 1446 Joan Greyndour gave those lands as part of the endowment of a chantry she founded in honour of her husband Robert, assigning a house called Blackbrook, evidently at the moat, as the priest's residence. The Crown sold the endowment of the chantry in 1559 to William Winter of Lydney, whose son, Sir Edward, sold the land at Newland to Thomas Baynham, owner of Clearwell, in 1596. Baynham's successors retained it in 1653, when the house was called Chantry or Charter House. About 1660 the land was acquired by William Probyn, and it passed to his descendants, owners of Newland House...


The site was described simply as the moat in 1757 and probably the house had by then been demolished. The moat survived in 1992, partly obscured by farm buildings and a slurry tip.


DAG Moated Sites Survey 1998.

Site has access through farm, permission obtained and proves to be a rectangular moat with a L-shaped house around it, and there are foundations visible further up the track.



#### NOXON

Hundred; St.Briavels Name: Noxon SMR:1010 Area 4391 Status:

NOT on Rawes map.

SMR Description: A large water filled pond visible adjacent to Noxon Farm. VCH.Vol.V.p.212 and note 76.

An estate called Noxon in the south-east part of Clearwell tithing was established in 1317 when the Crown granted John of Wyesham, then constable of St.Briavels, a fishpond and licence to assart 200a of Forest waste adjoining it...


The fishpond at Noxon in 1317 was probably on Oakwood brook on the north-east boundary; a large pond that adjoins the farmhouse appears to have been made later, before 1840.


note 76. P.R.O., MR879 marks a pond on the brook N. of Noxon Park wood. D.A.G.Moated Sites Survey 1998

Contact made with the landowner, Mr.D.J.Wright, who says:' The fishpond, as recorded in PRO.MR879, on the Oakwood brook, disappeared after the Oakwood Mill Deep Level was opened, and his family lost almost all sources of water on the farm. The large pond in front of the farmhouse was dug as a replacement, following compensation around 1800.'.
